## Youth Summer Savings Contest Rules

1. This contest is open to member of GR Consumers Credit Union who are 15 years of age or younger and legal resident of the United States at time of entry (excluding , without limitation, such resident if located in Puerto Rico and other US Territories). Employees of GR Consumers Credit Union and their immediate family member are not eligible.
2. Eligible members of GR Consumers Credit Union may enter the contest:
  - a. Receive one (1) drawing entry by depositing \$5.00 into your GR Consumers Credit Union savings account. Every additional \$25.00 deposit will earn you an additional entry. Maximum of four (4) entries allowed per account number. One (1) winner will receive a 2022 Family Pass to Rebounderz.
  - b. New memberships opened will also receive one (1) entry into a drawing for a Kindle Fire Tablet. One (1) entry allowed per qualified membership opened. If the winner drawn is age 0 – 8, the winner will receive a Kindle Fire Kid's Addition Tablet. If the winner is age 9 – 15, the winner will receive a Kindle Fire Tablet.

Existing or new direct deposits and automatic transfers do not qualify. All entries become the property of GR Consumers Credit Union, will not be returned, and are subject to verification.
4. GR Consumers Credit Union is the sponsor of this contest. All decisions of GR Consumers Credit Union in applying the contest rules will be final. GR Consumers Credit Union is not responsible for lost entries, misdirected entries, undelivered or late entries, computer or internet problems, hacking, viruses, technical or other issues beyond the reasonable control of GR Consumers Credit Union. Any account with uncharacteristic withdrawals, transfers and/or deposits between accounts to gain additional entries will not be eligible for prizes.
